We project that carbon emissions will decrease over the next five years to 999 tCO₂e by 2030. This is a reduction of 66% compared to our baseline year 2019.

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 baseline. The carbon emissions have reduced by 31% (360 tCO₂e) from our baseline year of 2019. This set against an increase in our business turnover of 23%

The Carbon Reduction plans we have implemented include:

80% of our vehicles are now all Electric 100% of office and warehouse lighting is LED / PIR 100% recycling of unusable Cardboard & Plastic 50% reduction in waste to landfill All plastic is 30%+ recycled composition. Certification to ISO14001 In the future we hope to implement further measures such as:

100% of fleet are Electric. Zero waste to landfill All plastic is 50% recycled composition. Air Freight transportation reduction
